Terms and Conditions:

- Reservations & Payments: Ascension Tours Travel requires a deposit of \$300 per person at the time of booking. This deposit is part of your final payment which is due 90 days prior to departure. A signed registration form is required to secure a spot. Reservations are accepted on a first-come, first-served basis. Please note that payments made by debit/credit card will incur a processing fee of 3.5%.
- **Insurance:** Insurance is not included in the tour price. We strongly recommend that you purchase insurance for your trip. Insurance is not effective until payment is received by the Insurance company.
- Travel Documents: If you have a U.S Passport, no visa is required. However, your passport must be valid for at least 6 months after the return date of the trip. If you are not a U.S citizen, please contact us to learn more about VISA requirements.
- **Baggage:** Passengers are allowed to bring one checked bag and one carry one. Ascension Tours Travel is not responsible for lost, delayed, damaged or stolen baggage.
- **Hotels:** Prices are based on double occupancy rooms. A limited number of single rooms are available at the supplement quoted and should be requested at the time of booking. Triple rooms are available with no reduction of price. In case we are not able to find a roommate for the traveler, the traveler will be required to pay the single supplement.
- Cancellation: All cancellations must be submitted in writing. Cancellation fees and penalties will be deducted from your refund. If canceled 46 days or more prior to departure, a \$300 administrative fee will be charged. If canceled 45-31 days prior to departure, a \$750 administrative fee will be charged. If canceled 30-15 days prior to departure, a \$1000 administrative fee will be charged. No refund will be made within 14 days of departure. Once the airline tickets are issued, 100% of the airfare is non-refundable.
- **Air Transportation and Taxes**: Airline taxes, port charges and fuel surcharges are included in the tour price. Any ticketing changes made within 90 days of your departure date are subject to airline penalties.
- **Medical Condition:** Tour Members are expected to be in good health. Tour members, who require any form of special assistance, must be accompanied by a helper who is totally responsible for those tour members.
- Seat Assignment: Tour flights do not have an advance seats selection. Please contact the airline directly.
- Responsibility: Ascension Tours Travel is responsible for making all arrangements for tour services offered in the itinerary. Ascension Tours Travel and/or co-operating selling agents or other suppliers of services are not responsible or liable for the service of aircraft, transfers, hotels, flights, motor coach, car or any conveyance, which may be used in the performance of its duty to the passengers. If the tour services, as indicated by the itinerary, cannot be supplied or there are changes in the itinerary for reasons beyond the control of Ascension Tours Travel. Ascension Tours Travel will arrange for provisions of comparable services. A minimum number of passengers (as noted in itinerary) are required to fulfill the tour itinerary and cost, otherwise the tour is subject to changes or cancellation. If Ascension Tours Travel cancels a tour, it shall have no responsibility beyond the refund of all payments made to Ascension Tours Travel. The passenger participant agrees that Ascension Tours Travel shall not be liable in any way for any changes in flight schedules, delays, weather conditions, damages, losses (including personal injuries and deaths) or expenses occasioned by acts or omissions of any person, including suppliers providing services, or for any other reason beyond the control of the tour operator. Tour operator reserves the right to substitute hotels of similar category if necessary and to change or reverse the sequence of activities in the itinerary. Please note that all fares and prices quoted at the time of publication are subject to change.

Any controversy or claim related to this contract will be settled in Flint, MI in accordance with local rules and laws. Should traveler sue Ascension Tours Travel and lose the case, Traveler agrees to pay all attorney fees and any other expenses that were caused to Ascension Tours Travel as a result of this lawsuit.
